

A crossbench Member of Parliament and Emeritus Professor of Philosophy, Baroness O'Neill was Principal of Newnham College, Cambridge from 1992-2006, President of the British Academy from 2005-9, chaired the Nuffield Foundation from 1998-2010, and has been a crossbench member of the House of Lords since 2000 (<u>Baroness O'Neill of Bengarve</u>).

 Dr Rachel Adams presented a paper on 'The Discourse of Transparency' at the International Institute of Social Studies and Erasmus School of Law conference on 'Human rights inside and outside', The Hague.

Publication of ILPC's written evidence on 'The Internet: To Regulate or Not to Regulate' from the House of Lords Select Committee on Communications.

The submission outlines four key issues:

- Whether Internet regulation could do more to enhance the protection of human rights;
- Whether Internet regulation could do more to enhance the protection of freedom of expression;
- The use of deceased's data (in response to Question 6 of the call to evidence: What information should online platforms provide to users about the use of their personal data?);
- The role of the UK as a world leader in Internet regulation.
